Londonwide LMCs' workforce survey

Our latest survey of London GP practices, conducted by ComRes, found that 35 are considering closure, half have a vacancy and two-fifths expect a GP to retire in next three years.

Department of Work and Pensions appeals template letter

We have produced emergency guidance for practice teams on how to manage requests for records in support of appeals against Department of Work and Pensions (DWP) decisions, including PIP (Personal Independent Payments).

The Government's data security review, run by Dame Fiona Caldicott - the National Data Guardian for Health and Care, has now produced a report containing ten proposed standards. The online survey is open until 7 September 2016.
