Media and public affairs round-up

On 2 December we briefed the HSJ and The Guardian on how GPs are going to handle the Omicron variant and the capacity available in general practice. On 2 December we also briefed The Observer on vaccine hesitancy and capacity. On 16 December Dr Michelle Drage, our CEO was quoted in the Independent on the reprioritising of GP services in response to the growth of the Omicron variant.
