



## Media and public affairs round-up

On 12 January Michelle Drage, our CEO, was quoted in Pulse regarding a London CCG informing GPs of urgent cancer referral waiting times of up to 40 days. On 1 January we shared a social media video thanking GPs for their work over the year. On 10 December Michelle was quoted in another Pulse article around APMS GP practices being funded £18 more per patient than GMS. We have also briefed HSJ journalists on how practices are dealing with increased staff isolation and delayed hospital procedures.
