OverviewTo help individuals to identify both the organisational and psychological

barriers to change and personal development. It introduces techniques to enable participants to overcome some of the challenges facing general practitioners and gain insight into the necessary changes that need to be made to their practice in the workplace in order to improve their working lives and

their ability to continue to deliver safe, effective and compassionate care.

The programme is aimed at those who face challenges with excessive workload, system changes and expectations from patients, commissioners and the media. It will provide a safe space for sharing concerns and identify needs, and aims to give participants tools and techniques to enable them to move forward and deal with constant changes in general practice and the wider NHS.
