## 1. LMC Elections 2018 – Speaking up for general practice

#### 2. GDPR - latest news

The General Data Protection Regulation (GDPR) came into force on 25 May 2018. We have produced a round-up of a significant amount of guidance to help you with integrating GDPR compliance into your practice systems.

- The Information Commissioner's Office (ICO) has just updated their website section on the right to be informed
- The ICO has produced an FAQs web page for <u>small health sector bodies</u>, a video on <u>data protection for small healthcare organisations</u>, and offers an advice service for small organisations.
- The BMA has a <u>dedicated GDPR web page</u> and NHS Digital has produced a <u>suite of GDPR resources</u>.
